

Player Waiver, Release of Liability, Indemnification

1. Agreement Roster

I, the undersigned player, acknowledge, agree and understand that:

- Voluntarily and of my own free will, I elect to participate as a member of Cuse Sports, LLC and or any team.
- I understand that there are certain risks and hazards involved in participating in kickball
 or any other sport that may result in injury or death to me or other players, including, but
 not limited to those hazards associated with weather conditions, playing conditions,
 equipment and other participants.
- I understand that sliding into base is dangerous to me and to other players and may result in serious injury or death.
- I understand that the very nature of the game of kickball and any other sport is
 hazardous and risky, including, but not limited to, the acts of pitching, throwing, fielding
 and catching of the ball, the kicking of the ball, running, jumping, stretching, sliding,
 diving, and collisions with other players and with stationary objects, all of which can
 cause serious injury or death to me and to other players.

Further, I, the undersigned player, agree that in consideration for the right to play as a member of any team and in consideration for permission to play on the fields arranged for by the team or Cuse Sports, LLC:

1. Assumption of Risk

I voluntarily elect to accept and assume all risks of injury incurred or suffered by me (a) while practicing or playing as a member of the team so designated, (b) while serving in a non-playing capacity as team member during practice or play by other teams or by other players on my team, and (c) while on or upon the premises of any and all of the fields arranged for by my team or Cuse Sports, LLC for practice or play.

2. Release of Liability

I release, discharge and agree not to sue the team, Cuse Sports, LLC, field owner or other entity, or any person or entity connected with the team and Cuse Sports, LLC. Costs or cause of action which I have or may have in the future as a result of injuries or damages, sustained or incurred by me from whatever cause including but not limited to the negligence, breach of contract or wrongful conduct of the parties hereby released.

3. Media Consent

I further understand that games, parties, functions, meetings and more may be photographed

or video recorded. This media may be used for advertising, promotions, website and more. I do allow Cuse Sports, LLC to use any media gathered for the manners mentioned without my consent.

I ACKNOWLEDGE THAT I HAVE READ AND THAT I UNDERSTAND EACH AND EVERY ONE OF THE PROVISIONS IN THIS WAIVER, RELEASE OF LIABILITY AND INDEMNIFICATION AGREEMENT AND THE SPORTSMANSHIP POLICY AND AGREE TO ABIDE BY THEM.

Cuse Sports Zero Tolerance For Poor Sportsmanship

Cuse Sports, LLC was started in the hopes of developing a social organization that at its core has a fundamental belief in sportsmanship, fair play and community building. It is the belief of Cuse Sports, LLC that all three of these important elements begin with individual members and extend to entire teams. Furthermore, it is the responsibility of every player, fan and supporter of Cuse Sports, LLC to ensure that they do their individual part to promote the core beliefs of Cuse Sports, LLC.

While the appropriate level of competitive play is expected in the appropriate leagues, it shall be understood that at no time should the Spirit of the game or any player, fan or supporter be made to suffer at its expense. Everyone is charged with the responsibility of developing a bond of mutual respect among all players, adherence to agreed-upon rules of play/conduct, promoting Cuse Sports, LLC and for fostering a love for recreational sports.

Actions such as taunting in an extreme manner, name calling, excessive profanity, dangerous aggression, intentional fouling, or other 'win at all costs' behavior are hereby strictly forbidden and are considered contrary to both the Spirit of the game and to the Mission of Cuse Sports, LLC and must be avoided by all players. **Failure to do so will have severe consequences.**

Zero Tolerance Policy

Cuse Sports, LLC has instituted a Zero Tolerance Policy for poor sportsmanship, extremely aggressive behavior, trash talking that does not fit within the Cuse Sports, LLC code of conduct and for any behavior that is "contrary to the Spirit of the Game." Furthermore, excessive profanity, especially stemming from disagreements or during taunting will not be permitted and will be considered an example of poor sportsmanship and will be subject to penalties.

Team Responsibility

ENTIRE TEAMS WILL BE PENALIZED FOR THE BEHAVIOR OF INDIVIDUAL MEMBERS.

Teams are expected to police the behavior of their members for the entire duration of the season at hand regardless of whether or not they are currently playing. Any extreme behavior occurring in the stands, after games or at any later date anywhere Cuse Sports, LLC members are assembled will be subject to the same penalties. Understand that if any member of a team or person known to be associated directly with that team is ejected from the game or park for any violation or if a person is a constant source of controversy, THE ENTIRE TEAM MAY BE SUBJECT TO PENALTY.

Fines and Ejections

Any player ejected from a game for any reason will be fined **\$50.00** before they can play in another game. Captains are expected to be the first line of prevention and expected to police their members. If you cannot control a person on or off the field, you are expected to remove them from Cuse Sports, LLC for the benefit of your team, fellow players and for the good of the league. If not, your entire team will suffer penalties. No exceptions.

Penalties

Cuse Sports, LLC Directors will investigate all infractions fairly and aggressively and everyone is reminded of the following fact: as commissioners of this league, we will have final say on all matters. We also reserve the right to consult with anyone we see fit. If warranted, any of the following penalties may be additionally imposed for unsportsmanlike conduct or any behavior that is "contrary to the Spirit of Cuse Sports, LLC Leagues":

- (a) The offending individual may be banned from all future Cuse Sports, LLC events and will not be allowed in Cuse Sports, LLC facilities.
- (b) The offending player's team may be further penalized with a 1 week suspension meaning any games scheduled for the following week will be forfeited and the team and its members will not be permitted in Cuse Sports, LLC facilities.
- (c) The offending team may be dropped from the remainder of the schedule or season. No refunds will ever be issued.
- (d) The offending team and any players associated with that team may not again be allowed to participate in Cuse Sports, LLC; penalties are not limited to only those listed.

Playoffs and Tournaments

Any violations occurring during playoffs, tournaments or charitable events will be considered the most extreme and teams may be immediately forfeited from the remaining games.

Additionally, if that team participates in the next season, they will forfeit their first game 7-0.

Team Eligibility

No team will be allowed to participate in Cuse Sports, LLC with 3 or more members from a previously banned team. It is the responsibility of captains to ensure their team is aware of Cuse Sports, LLC's Zero Tolerance policy.
